Liberty offering

Our maximum capacity is US\$50,000,000 for either:

Our specific capacity limits are:

- ▶ Financial loss \$25m
- ▶ Professional indemnity \$10m
- ▶ Statutory liability \$5m
- ▶ Environmental impairment liability \$25m
